Organisational structure:

Service Public Fédéral Emploi, Travail et Concertation sociale (Federal Public Service Employment, Labour and Social Dialogue) was established in 2003. It comprises 5 Directorates-General (*directions générales*), including *DG Contrôle des lois sociales* and *DG Contrôle du bien-être au travail* which fulfill the tasks of labour inspection and which engage with the National Labour Inspectorate in exchange of information on posted workers (Directive 96/71/EC of 1996).

Areas of activity:

- *DG Contrôle des lois sociales*: inspection of general terms and conditions of work, remuneration and employment, inspection of working time (overtime work, days off, night work), collective labour agreements, cooperation with social partners, legality of employment (employment contracts, temporary work, posting and hiring out of workers), inspection of the register of employers, social insurance, employee benefits, leaves;
- *DG Contrôle du bien-être au travail*: technical inspection (occupational safety and health), occupational medicine, work accidents – prevention, inspections, decisions, inspections in high risk companies, inspection of chemical risks, conditions of work and safety in mines, supervision of the works of the industrial toxicology laboratory, supervision of compliance with legislation on well-being at work, legality of employment.

Our cooperation:

Within the framework of the agreement on cooperation, the National Labour Inspectorate and the Federal Public Service Employment, Labour and Social Dialogue engage in active cooperation and information exchange between liaison offices in line with the stipulations of Directive 96/71/EC on the posting of workers in the framework of the provision of services.

Areas of cooperation:

Service Public Fédéral Sécurité Sociale (Federal Public Service Social Security) fulfills three main strategic tasks :

- coordination and support of the social policy;
- ensuring access to social benefits;
- participation in combatting social fraud.

SPF Sécurité Sociale comprises two Directorates-General: *DG Personnes handicapées* [DG Persons with disabilities] and *DG Soutien et Coordination politiques* [DG Political Support and Coordination].

The main task of DG Persons with disabilities is to award social benefits to adult disabled persons on the basis of a medical certificate of disability and an examination of income and family situation, and to issue certificates allowing disabled persons to benefit from certain tax reliefs and social allowances. Its task is also to assess the level of disability in children in order to award additional family benefits.

DG Political Support and Coordination ensures necessary support as regards coordination, regulations, examinations, analyses, budget, indicators and international representation to key policy makers in Belgium (ministers, state secretaries, social partners, public social insurance institutions).
